ESTATE PLANNING FOR FAMILIES WITH DISABILITY

Families with disability in the mix need more than a simple Will. Their needs are complex and their Wills need to be also. To adequately provide for disabled children (especially intellectually disabled), protective trusts should be built into their Wills. Parents can protect these children from their inability to manage large sums of money, and also from unscrupulous persons that may take advantage of that child's vulnerability.

Ask yourself these questions:

- If your child came into say \$200,000 would they know what to do with it?
- Would they spend it wisely?
- Would it disappear on trivial items?
- Would they 'loan' some/all of it to anyone on the promise it would be repaid?

If the answers to these questions alarm you, it's time to do something about it. It's time to revisit your Will with protective trusts in mind.

Q: What types of protective trusts should I consider?

There are 2 main protective trusts that parents of special needs children can build into their Wills. A Special Disability Trust and an All Needs Protective Trust. Each trust has a different function and different limitations. One provides for accommodation only and must meet the criteria of Centrelink guidelines. The other is more flexible covering other aspects of support such as provision for entertainment, travel and education. It is wise to incorporate both protective trusts in your Will so as to provide maximum flexibility/options for your child during their adult life.

Q: Who should I appoint as trustees for a protective trust?

Protective trusts are managed by Trustee(s). This can be a natural person or a trustee company that you appoint in your Will.
