## ESTATE PLANNING – WHO TO APPOINT?

Some of the most difficult decisions that need to be made when addressing your Estate Planning are who to appoint in the major roles of:

- Executor
- Trustee
- Enduring Powers of Attorney (Financial, Medical & Personal).

Most couples appoint each other to these roles, however it is advisable to have 'second tier' or 'alternative' appointments in place. If you both die together or are, for example, in an accident where one party dies and the other is seriously injured and unable to make decisions, another person would need to step in to make decisions on your behalf. These appointments are even more significant when the life-long needs of a special needs child are factored in.

Elements to consider when selecting your appointees:

- <u>Distance</u> family or friends who live a long distance from you may have difficulty in acting on your behalf when immediate decisions would need to be made, particularly medical. Someone who lives nearby would more easily be able to act effectively.
- <u>Age</u> as your family members or friends age, their ability to make decisions not only for themselves but you may begin to wane. Similarly, nominating someone who is young may have its own challenges around inexperience and naivety.
- Role Suitability consider how suitable your family member or friend is for the role you would like them to perform. For instance, a person that struggles to manage their own finances may not be suitable as a Financial Attorney or Trustee.

#### **FAMILY LOANS**

When family members help each other out financially, little thought is usually given at the time as to whether the help is a **gift** or a **loan**.

Even less consideration is given to documenting the arrangement.
