SUPPORTED DECISION MAKING

Every person has the right to make their own decisions. For persons with cognitive disability this right extends to receiving whatever support is needed to assist this process.

A variety of newly enacted laws in Victoria recognise the right to receive decision making support for decisions with legal consequences. The legal framework now exists for an adult person with a cognitive disability to appoint a trusted person to the role of supporting their decision making.

Legally recognised roles for decision supporters include:

<u>1.</u> <u>Supportive Attorney</u> (personal & financial) is appointed by a person to support them to make and act on their decisions. The scope of Supportive Attorney is for support with personal and financial decisions.

<u>2.</u> <u>Support Person</u> (medical) is appointed by a person to help them make, communicate and act of their medical decisions. This appointment may also be made by a minor (under 18 years of age) who has decision making capacity. The scope of Support Person is for support with medical decisions only.

3. <u>Nominated Person</u> (mental health) is appointed by a person who is receiving mental health services, to represent their best interests in the event that they become a patient under the Mental Health Act. This includes receiving information and being one of the people consulted about the patient's treatment in accordance with the Act.

<u>4.</u> <u>**Plan Nominee**</u> (NDIS) is appointed by an NDIS participant to act on their behalf. A Plan Nominee has a duty to ascertain the wishes of the participant and act in a manner that promotes the personal social & wellbeing of that person.

5. <u>Supportive Guardian*</u> (personal) is appointed by VCAT with the Principal's consent, to provide support with personal decision-making.

<u>6.</u> <u>Supportive Administrator</u>* (financial) is appointed by VCAT with the Principal's consent, to provide support with financial decision-making.</u>

The appointment of persons to these roles may depend upon the Principal's level of mental capacity.

*Supportive Guardian & Support Administrator roles are applicable where a Principal has more limited decision making capacity. These laws come into effect on 1 March 2020.

Appointing persons to support decision making both empowers and assists persons with cognitive disability to navigate their way in a complicated world, and sort out problems that may arise. As an appointed person, privacy barriers that would otherwise preclude you from participating in discussion about the Principal's affairs are bypassed.

Special Disability Trust Update:
